## AT THE INDUCTION CENTER

It is important to remember that you are a civilian until your name is called at the end of the final induction process and you take a step forward. Don't let the military shove you around. They may threaten you and they will surely try to give you the impression that you are already under orders. They will tell you that you will get in trouble by not co-operating. In fact, you may well be in a lot more trouble if you do co-operate unknowingly. As a civilian, at the pre-induction physical, you may legally:

a) refuse to be fingerprinted if ?asked.

b) refuse to sign the security-loyalty oaths #DD98 and #DD398. You could cite the 1st Amendment (freedom of association) and 5th Amendment (against self-incrimination) as reasons for not signing. Although not signing the loyalty oaths does not automatically keep you out, it usually does delay your induction a couple months for a Military Intelligence Check.

c) express your opinion about the war and the draft in the section reserved for comments on the security-loyalty form. If you are opposed to the war or to being drafted, you could let them have it here. It is legal for you to write anything you wish. The security-loyalty forms

may not be given out until the final induction process.

## REFUSING INDUCTION

Many men today are refusing induction into the armed services. The examples of such men as Muhammed Ali give strength to our movement. It encourages others to make a similar commitment. If the government decides to prosecute, a person convicted is subject to up to 5 years in prison and/or \$10,000 fine. The fine is hardly ever invoked and most sentences are running two to three years (usually less with "good time." If you refuse induction we would like to publicize your case as an inspiration to others and as a stimulus to anti-draft organizing. We can't promise you a lawyer in such cases, but we will do all we can to raise bail for you and get you legal assistance.

## WHAT THE STANFORD ANTI-DRAFT UNION WANTS TO DO

We wish to provide you with all the information necessary for a man resisting the draft. You have every right to know your legal alternatives and the consequences of actions considered "illegal" by the immoral and coercive system. We can't make decisions for you, but we will help you find out the alternatives. We want you to have all the information you need so that you will have a choice a choice the Army isn't about to tell you about. You deserve to hear our perspective because it is we, not Lyndon Johnson, who are being asked to kill and

In the long run, we must be more than just a service organization. We must band together to form a movement of people committed to abolishing the discriminatory, undemocratic, and coercive system which destroys our lives and the lives of innocent people throughout the world. WE MUST STOP THE DRAFT.
