At a meeting of El Tigre Club the following resolution was passed with approximately 3/4 of the members voting:

We, the members of El Tigre Club.

- 1. Express our full support for the demands of the April Third Coalition to end research performed at SRI and on the Stanford campus in the following areas:
  - a. Chemical and biological warfare.
  - . b. Counterinsurgency.
    - c. Classified research
    - d. All other war-related research.

(93% approved)

- 2. Express our support for the April Third Coalition's demand for an open decision-making meeting to decide SRI's future. (88% approved)
- 3. Support the tactics and actions of the April Third Coalition which have brought these demands to the attention of the entire community. (69% approve
- 4. Call for amnesty for all those involved in the sit-in at the AEL as long as they maintain adherence to those principles decided on at the April 9 meeting. (52%:approved)
- 5. Add our voices to those calling upon the Stanford Board of Trustees to understand the seriousness of the community's concerns in these areas and to realize the strength of our commitment to bring an end to the University's complicity in American militarism. (78% approved)

## WE, THE UNDERSIGNED MEMBERS OF BURBANK HOUSE, DO HEREBY PUBLICLY AFFIRM THAT WE:

- 1) Deplore all forms of research in chemical and biological warfare, counterinsurgency, and other warfare tactics and practices now being carried out at Stanford and SRI, edpecially as this research relates to present U.S. involvement in S.E. Asia. Further, we call for an immediate end to all such research on the Stanford campus and at its affiliated research centers.
- 2) Believe that all forms of classified research should be banned from the University, unless it can be convincingly shown that such research is directed solely toward the causes of peace and the betterment of life in our world.
- 3) Support the non-violent sitin now in its seventh day at AEL, the understood purpose of which is to help bring about immediate and constructive changes at Atanford with regard to the above-named concerns.

The above statements were presented to the members of Burbank House, Stern Hall, in the form of a petition, with the understanding that signees could indicate support of any or all of the statements as they chose. Of 62 house members (67% of total membership) polled, the response was as follows:

- 1) 46 members, or 74% of those polled, supported statement One.
- 2) 41 members, or 66% of those polled, supported statement Two.
- 3) 35 members or 57% of those polled, supported statement Three.

The following is a resolution passed by the residents of Cedro House in Wilbur Hall. It is addressed to the trustees with copies sent to President Pitzer, the AEL Community, KZSU, and the <u>Stanford</u> Daily.

## RESOLVED:

We, the residents of Cedro House, Wilbur Hall, support the following:

- 1) We wholeheartedly support the goals and demands of the April 3 coalition. Stanford's and Stanford Research Institute's involvement in chemical and biological warfare, counter-insurgency, and war related research must be ended by immediate action of the Board of Trustees.
- 2) We endorse the tactics of the AEL sit-in, insofar as its non-violent nature is maintained, and that all democratic procedures continue to be implemented in the decision-making process.
- 3) We contribute \$50.00 from house funds to the payment of bills incurred in the use of AEL printing facilities.
- 4) We urge that no disciplinary or legal action be taken against those sitting-in at the AEL for their non-violent actions there.

With 92% of the house voting, the above statements were endorsed by the following majorities:

- 1. 70%
- 2. 77%
- 3. 64%
- 4. 86%

WE CALL ON OTHER CAMPUS LIVING GROUPS TO JOIN US IN SUPPORTING THE APRIL 3 MOVEMENT

- 1. We, the residents of Junipero House, Wilbur Hall, support the goals of the \$RI coalition:
  - A. Closer control by the University of SRI, including immediate cessation and future non-acceptance of research at both Stanford and SRI in the areas of chemical-biological warfare, and counterinsurgency at home and abroad.
  - B. Cessation and future non-acceptance of other research in support of ;the wars against the prople of Vietnam, Thailand, and Laos, classified research, especially classified military research.
  - C. An open decision-making meeting later this month on control of SRI.
- II. We further support the use of the sit-in at the Applied Electronics Laboratory, as conducted until now, to implement these goals.
- III. Since research originates with the faculty we urge that they personally assume the responsibility for reevaluating their own projects.
- IV. We urge that no disciplinary or legal action be taken against those sitting in at the AEL for their non-violent actions there.
