

(1) Cease all CBW research at SRI and Stanford

The DoD is presently financing \$404,000 of research directly related to CBW at SRI; there are \$98,000 worth of contracts pending. No Stanford profs are doing any CBW research now, though there were from 1959-62.

A definite guideline for a review board would be to terminate any present CBW research and turn down any future CBW research funded by the DoD. The review board should evaluate and have the authority to turn down any other research that might be applicable to CBW from other gov't agencies and from corporate sponsors.

The distinction between "offensive" and "defensive" CBW is largely a false one, since "defensive" research beyond medical work in diseases etc. involves the creation of offensive CBW agents and delivery systems against which to test the "defensive" techniques. Let the PHS and NIH finance medical research.

A review board must also turn down any research that might be applicable to CBW that involves obtaining classified input material or publishing classified results.

(2) Cease all Counterinsurgency research at home and abroad

(3) Cease all research in support of the wars against the peoples of Vietnam, Laos, and Thailand.

Counterinsurgency refers to military operations and social science techniques directed toward suppressing insurgent or nationalist revolutionary movements, whether they be in Vietnam, Thailand, Peru, or Oakland.

SRI presently has \$6,236,000 in DoD contracts relating directly to the war efforts in SE Asia. SRI researchers have done "cost-analysis studies of alternative reconnaissance routes (road bombing routes) over North Vietnam". They are also working on the electronic Huginot line in the DMZ. SRI presently has 43 ~~XXXXXXXXXXXX~~ permanent staff members at the Thai-US R&D Center in Bangkok working on contracts such as "Counterinsurgency requirements for Thailand." SRI's Vietnam researchers have worked on a "land reform" program for the Ky-Thieu government, and SRI's Thai researchers have written ethnographies of "unstable areas" in Thailand. SRI has also done counterinsurgency work for the DoD in Peru and Honduras.

A clear guideline for the review board would be to terminate SRI's \$6.2 million of DoD contracts related directly to SE Asia, and to turn down any future contracts of that nature. The board should also turn down ~~XXXXXXXXXXXX~~ social science research ~~XXXXXX~~ such as the Vietnam land reform work which is directly assisting the war effort. The board should also terminate present ~~XXXXXX~~ contracts and turn down future ~~XXXXXX~~ contracts related directly to Latin America.

The Stanford Electronics Laboratory is presently doing over \$2.2 million in classified, applied military electronics work for the DoD. Electronic warfare research done in the early 1960's is now being used in Vietnam (jamming of radar-directed anti-aircraft fire etc.); techniques being developed now will assist counterinsurgency operations in the 1970's.

A review board should oppose this work ~~XXXXXXXXXX~~ both because it generates classified reports to the Pentagon and requires access to classified material and because it adds to the US's ability to wage future wars. The University Committee ~~XXX~~ on Classified Research has not performed satisfactorily in this area.
