AFFIDAVIT OF TIMOTHY LAWSON

- I, TIMOTHY LAWSON, say and declare:
- 1. I am a photographer for Stanford News Service.
- 2. On May 1, 1969, from approximately 7.30 am. until approximately 8.00 am. I was at Encina Hall, which is located on the principal academic campus of Stanford University. My purpose in being at this location was to photograph the events that were taking place both inside Encina Hall and outside in the area surrounding Encina Hall.
- 3. I was using a Nikon F camera, type 35 mm. with a normal type lens. The focal length and correction were 50 mm. The lens was about five feet above the ground and it had an opening of F 1.4. I was using no filter and the shutter speed was 1/60 second.
 - 4. I was using TRI-X film, size 35 mm.
- 5. I personally took each of the photographs that are attached as exhibits to this Affidavit.
- 6. Exhibits 1, 2 and 3 (photograph 5/5A, 6/6A and 11/11A) were taken on the third floor of Encina Hall in the office of the General Secretary at approximately 7.45 am. These photographs accurately represent the condition of the portion of the office of the General Secretary depicted therein as of the time such photographs were taken. At about the same time that these photographs were taken I also noted that the office of the General Secretary was generally littered with papers, files and other office materials.

Police officers Charlie Blalock and Kenneth Pasquinucci, both of whom are employees of Stanford University, were present at the time these photographs were taken.

7. Exhibit 4 (photograph 7/7A) was taken on the third floor of Encina Hall in the office of the News and Publications Service at approximately 7.45 am. This photograph accurately represents the condition of the portion of this office depicted therein as of the time such photograph was taken. At about the same time that this photograph was taken I also noted that the office of the News and Publications Service was generally littered.

Police officers Charlie Blalock and Kenneth Pasquinucci, both of whom are employees of Stanford University, were present at the time this photograph was taken.

8. Exhibit 5 (photograph 15/15A) was taken on the second floor of Encina Hall in the Controller's Office at approximately 7.45 am. This photograph accurately represents the condition of the portion of the office of the Controller depicted therein as of the time such photograph was taken. At about the same time that this photograph was taken I also noted that the office of the Controller was generally littered with papers, files and other office materials.

Police officer Kenneth Pasquinucci, an employee of Stanford University, was present at the time this photograph was taken.




