DECLARATION OF
WILLIAM W SCHWARZER

28 My name is William W Schwarzer.

29 I declare as follows:
30

1 On Friday, May 2, 1969, at about 9:30 A.M. I received
2 a telephone call in my office from Mr. Wolpman. He said that he
3 had made an appointment to see Judge Evans at 4:30 that afternoon
4 to have the temporary restraining order vacated or modified. I
5 told him it would be difficult for me to be there. He replied
6 that he was giving me notice as a matter of courtesy and intended
7 to proceed in any case. I then told him that someone from our
8 office would be there.

9 I then instructed my associate, Mrs. D. Stoppello, to
10 prepare to go to Palo Alto and attend the meeting. She did pre-
11 pare during the day and left at about 3:00 P.M.

12 At 3:30 P.M. Mr. Wolpman called again to say that his
13 clients, whom he did not identify, had instructed him not to
14 meet with the judge after all.

15 I declare under penalty of perjury that the foregoing
16 is true and correct.
