LABOR-STUDENT ANTIWAR RALLY

A labor-student antiwar Memorial Day rally will be held at San Jose State quadrangle this Saturday, May 30. The rally is being cosponsored by the Santa Clara County Central Labor Council and the San Jose State Associated Students Committee on Student - Labor Relations.

The speakers will include Don Duncan, former Green Beret; Terrence Hallinan, San Francisco attorney; Paul Schrade, Western Region Director, United Auto Workers; James McLoughlin, secretary-treasurer of the Santa Clara County CLC; Al Richmond, labor journalist; Mary Lou Greenburg, Santa Clara County Workers Committee; Rafer Johnson, olympic medal winner; Concha Barrozzi, United Farm Workers; Dr. Halstead Holman, Head of the Department of Medicine; James Edwards former SJS Student Body President; and John Vasconcellos, assemblyman.

Several noted entertainers will also appear. They are Pat Paulsen, Joan Baez, the Guerrilla Theatre, and John Stewart, of the Kingston Trio.

ADVERTISING FOR A BETTER SOCIETY

A new advertising agency pledging 20 percent of its time and talent to fight war, racism, waste, and poverty is opening this month in San Francisco. An ad in the May 25 issue of TIME maintains that the "best creative and managerial talent today is determined to take some part in helping with the great social problems of our time." The new company believes that "a company that can offer both creative and moral opportunity... will attract the best talent in advertising."

At present the agency wants concumer accounts and, without fee or commission, an anti-war account, an anti-racism account, and anti-waste account, and an anti-poverty account. The company is the Maxwell Arnold Agency.

LABOR COUNCILS - ANTIWAR RESOLUTIONS

Three area Central Labor Councils
have passed resolutions opposing the
Southeast Asian war. The Alameda County
CLC resolution calls for repeal of the
Gulf of Tonkin Resolution, passage of the
Hatfield-McGovern bill, and censure of
President Nixon for "his election, dishonesty, and violation of our Constitution." The Santa Clara County CLC and
the Contra Costa County CLC have adopted
similar resolutions.

Copies of the resolutions are to be sent to the State Labor Federation, AFL-CIO President George Meany, congressman Don Edwards and Charles Gubser and President Nixon.
