STANFORD -- Ballots will be mailed July 7 to 86, 000 Stanford alumni who will vote for their representatives to the Board of Trustees for the first time in the University's history.

Eighteen candidates, divided into "36 and over" and "35 and younger" age categories, will vie for four seats on the University's governing board. Two will be elected from each age bracket.

The candidates include several businessmen and attorneys, as well as a minister, a researcher, a professor, a young black executive, and the director of the National Environmental teach-in.

Of the 18, six were nominated by petition and 12 were selected by a nominating committee. Those qualified by petition in the age 36 and over group are: Wayne E. Alley, a career Army attorney who will be appointed military judge of the Army's 10th Judicial Circuit-Pacific; Joseph J. Burris, attorney and partner in Burris and Lagerlof, Pasadena, and James S. Triolo, vice-president of the University of Willamette and former vice-president of the Salk Institute, La Jolla, and the Graduate Research Center, Dallas.

In the age 35 and younger group are: James D. Palmer, Menlo Park attorney and former administrative assistant, California Legislature; Philip F. Schneider Jr., Phoenix attorney and past president of the Phoenix Alumni Club; and Stender S. Sweeney, director of finance, Times-Mirror Co., Los Angeles.

Alley, Sweeney, Burris are running as a ticket.

Those nominated by committee, and announced earlier, include the following age 36 and over:

Mrs. John J. Cashel Jr., of Lafayette, Calif., of Monarch/Mackenzie Securities, San Francisco.  
Najeeb E. Halaby of New York City, president and chief executive of Pan American World Airways.

James Calvin Haugh of San Diego, vice president of City Transit Systems.

Raymon Howard Mulford of Toledo, Ohio, chairman and chief executive officer of Owens Illinois, Inc.

The Rev. George A. Selleck of Los Angeles. A United Presbyterian Church pastor and former basketball star.

Alan Norman Weeden of Larchmont, N.Y., president of Weeden & Co., investment bankers. The remaining candidates 35 and younger:

Mason Elvin Byles of Palo Alto, Hewlett-Packard, is division manager of human environment.

David Carson Cox of Santa Monica, secretary and marketing manager of Lawrey's Foods, Inc.

Thomas E. Cronin of Bethesda, Md., researcher at Brookings Institution in Washington.

Ira De Voyd Hall Jr. of East Palo Alto, executive director of the Mid-Peninsula Urban Coalition.

Denis A. Hayes of Washington, D.C., national coordinator of the Environmental Teach-In, and former ASSU president.

W. Scott Thompson of Cambridge, Mass, associate professor at the Fletcher School of Law and Diplomacy, Tufts University.

Ballots from the summer election are to be returned by Aug. 15 to Field Research, Inc., San Francisco, which will tabulate the results.

The election is part of a planned expansion in Board membership from 23 to 32 members. In addition to having the University president serve ex-officio, the change calls for the election of four additional alumni trustees---two in 1971 and two in 1972.
