Provost William F. Miller of Stanford Wednesday afternoon, April 14, received a list of 11 demands from a newly formed Stanford Employees Coalition calling for reinstatement of Sam Bridges, dropping of all legal charges, and payment of legal and medical expenses for those involved in last week's occupation of the hospital.

James Cheatham of the Black Advisory Committee gave the demand to Provost Miller on the lawn outside the Medical School and set a 9 a.m. Monday deadline for a reply. Tony Rodriguez of the Latin American Alliance and Willie Newberry of the Black Student Union were present when Miller read the demands over a microphone, said "we will be getting people together to start these discussions," shook hands with Cheatham and left.

Other demands included having Dr. John L. Wilson resign as acting dean of the Medical School, granting tenure to Dr. Jose Aguilar, sole chicano on the Medical School faculty, and having a black and Latin committee empowered to "evaluate the policies, practices and procedures" of all departments in the Medical Center, including development of an affirmative action program and evaluation of the Personnel Department.

Further demands included having Stanford employee medical coverage include spouses, clear job descriptions and salaries, having four black and Latin delegates added to the Administrative Council of the hospital, and providing up to six months leave time for "acceptable and legitimate" reasons without job loss.

Besides Dr. Wilson, the employee group called for having Deputy Hospital Director Frank Vitale and Warren Thorpe, assistant chief of engineering [and Bridges supervisor] relieved of all Medical Center, duties, with a black and Latin committee approving their replacements.

Provost Miller asked Cheatham and others present to designate the individuals from their group who would participate in the discussions.

Late Wednesday, the employee group issued a four-page statement charging Dr. Wilson with "numerous inaccuracies" in a statement which he circulated concerning the chronology of the sit-in.

Attacks on at least three members of the conservative Free Campus Movement (FCM) were reported Tuesday, April 13, following an "eat-in" at Tresidder Union.

The Stanford Daily reported that 20 to 30 black students chased, knocked down, beat and kicked FCM chairman Ray White, Steven Guerra, and Ed Jagels after Guerra was spotted taking pictures of the blacks.

The blacks, according to Tresidder officials, loaded their lunch trays and walked to the outside patio without paying for the food.

Forrest Tregea, manager of the Union, reported that about \$100 worth of food was taken, including some "who went back for seconds."

Afterward the blacks dumped trays, dishes and silverware in nearby trash cans.

Incensed because their pictures were being taken by FCM's Ray Guerra, the black students pursued Guerra and five other FCM members around the Union and into the parking lot, where one person was caught, tackled and kicked.

Others of the FCM group fled to Salvatierra St. and Campus Dr. where the blacks again knocked White and Guerra to the ground. Guerra was kicked, his camera taken from him, and his film exposed.

Returning to the Post Office area, the group spotted Jagels and chased him across the street where he was also knocked down and kicked by two or three members of the black group.

Guerra said \$100 worth of damage had been done to his camera. He could not identify his assailants.
