FRANKLIN CASE DECISION DUE SOON

The Advisory Board is now deliberating over transcripts and briefs trying to decide if Bruce Franklin should be fired for his actions last year. Two weeks ago the board recieved the final briefs from Franklin and the Administration.

On the question of standards, the University states: "In developing the 'law', it is entirely reasonable to require a faculty member to adhere to standards which would not be required of a man in the street." In other words, constitutional rights need not apply at Stanford.

The board is taking a long time to make up its mind. That is because the decision is going to be based far more on the political aspect than the factual ones. The question the Board is trying to resolve is whether it is necessary and more important to protect the university status quo than it is to give faculty and students the freedoms granted by the constitution.

The decision will be out in the next week or so. If they decide to fire Franklin, we know from last quartor that the community will not stand lor it

Last spring the Student Senate sent a proposal for reform of the Stanford Judicial Council to the appropriate university committee. Stalled by the administration, the proposal was never even considered. In response, the senate has refused to appoint a studend committee to choose new student members for the SJC. President Lyman, using his emergency powers, has set up a s' new procedure -- the Interim Judicial

The IJF will have a hearing officer from outside the university to hear the charges against students. He will be chosen from a group of local lawyers. A panel of 3 professors, 3 students and Kaplan will rule on the hearing officer's decisions.

Meanwhile, Prosecutor John Schwartz, is devising new rules for the LJP. The rules will allow the panel to suspend anyone who "disrupts" hearings or witnesses who refuse to incriminate themselves after being given immunity from university prosecution, which is a violation of the constitutional right to the protect-Jun of the 5th Amendment.

The first case to be tried under these procedures will be Mike Molman's, which is already triple jeopardy -he has a civil suit, injunction violation and now IJP charges against him, all stemming from the same incident. Who does this judicial system protect? The Stanford community, when they do, we will be ready for

WAR CRIMINAL RETURNS TO AREA!

David Packard, one-time Chairman of the Board of Trustees, is coming back. He has resigned from his post. in the Defense Department and is returning to Palo Alto to resume his presidency of Hewlett-Packard, the world's largest manufacturer of electronics testing equipment, and a major war-profiteer. Whether or not he will also resume his position on the Stanford Board of Trustees is an open question. Packard has continually emphasized the connection between the aircraft and electronics industries and the laboratories at Stanford. His work will continue to be directly related to America's war on Indochina as it depends more and more on aircraft and advanced electronic systems. He is clearly partly responsible for the recent bombings of North Vietnam, and he will undoubtedly continue to increase Stanford's involvement in the

In a speech in the City last September (the geople had driven him out of Palo Alto), Packard said that Stanford is infiltrated by a "hard core" that "will have to be eliminated," also that tension in this country will have to come to a head some day "and it might as well be now --- we agree. David Packard is coming back, we need to propare a proper welcome here at his alma mater.

> RENEWED BOMBING OF NORTH VIETNAM SIGNIFIES U.S. FAILURE

The United States is suffering disasterous military defeats in Cambodia and Laos. In Cambodia in particular the puppet regime is on the verge of collapse. This is the beginning of the dry season offensive. Phnom Phenh is surrounded and the Pathet Dac have already retaken the Plaine des Jarres. Bombing short of total annihilation, has never in the past halted the liberation forces and is more of a threat than a physical deterrent.

The U.S. recently launched five days of intense bombing against the North, and it is threatening Hanoi that it will continue the destruction eration forces in Cambodia and Laos This is the real reason for the bombing. Bombing Hanoi as a "protective reaction" is a tactical cover-up for strategic responses to military defeats elsewhere in Indochina. All
